- 4. Insurance:** I, the Volunteer, understand that the Ministry does not assume any responsibility or obligation to provide me with financial or other assistance, including medical, health, or disability coverage in the event of injury, illness, death, or property damage.
- 5. Confidentiality:** I agree to respect the confidentiality of all proprietary or privileged information to which I am exposed while serving as a volunteer, whether this information involves Ministry staff, volunteers, or other persons.



6. **Code of Conduct:** I agree to abide by the Ministry's policies and procedures including compliance with the Ministry's code of conduct.
7. **Participation of Minors:** If I am executing this release on behalf of a minor child, I acknowledge that I have the legal capacity and authority to act on their behalf and will assume full responsibility for any risks or liability for the minor's participation in the Ministry's activities.
8. **Photographic Release:** I grant and convey to the Ministry all rights, titles, and interests in any and all photographic images and video or audio recordings made by the Ministry during my work for the Ministry.
9. **Governing Law:** This Agreement is governed by the laws of the state of Kentucky.
